REVITALIZATION IS MOVING FORWARD!

Your Rights

- Residents in good standing will sign a new lease before temporarily relocating.
- Residents in good standing will maintain their right to return following revitalization.
- Residents will continue paying approximately 30% of their income toward housing costs.
- Relocation and revitalization costs will be paid by the project – **not by residents**.

What to Expect

- Revitalization work will occur in smaller phases to help minimize disruption.
- Phase 1 site work is anticipated to begin in **June 2026**.
- Temporary relocation during construction is expected to last about 3-4 months.
- Residents may temporarily relocate within Golden Gate Village or choose another available housing option.
- Residents will return once work on their building is complete.

Project Facts

- NO** residential buildings will be demolished.
- NO** new residential buildings will be constructed.

Phase 1A Residents – Get Prepared

The revitalization will be completed in two phases. Phase 1 sitework is anticipated to begin in June 2026 with the first residents temporarily relocating in July.

- Finalize your relocation plans with the Relocation Specialist.
- Begin lease up with Burbank Housing Property Management.
- Refer to your Moving Checklist and Resident Resource Binder and begin preparing now.
